

INSTRUCTIONS FOR FILLING OUT FORM

PURPOSE. This form is to be used within 45 days of being appointed guardian. Within 45 days after the appointment of a general guardian or guardian of property, the guardian shall prepare and submit to the Court an inventory and appraisal of the assets of the estate. The appraisal must be made by at least one disinterested person who is required to certify under oath to the appraisal and may be awarded reasonable compensation for their services upon application to the Court by the guardian and approval of the court.

The disinterested person who makes the appraisal must not have an interest or stake in the estate or be related to or a close friend with the guardian or the minor child(ren).

FORM INVOLVED. The form is an **Inventory and Appraisal**. You will need to find a disinterested party to make the inventory and appraisal by filling in the necessary information with help from the instructions below and then file the form with the court.

How to file the Inventory and Appraisal. You must file the Inventory and Appraisal form by filing the original with the court.

INSTRUCTIONS FOR FILLING OUT THE FORM. To fill out this form follow these instructions. The numbers to each instruction below is the number on the blank line on the form where the information for that number needs to be inserted on the form.

Instructions for filling out the financial statement:

- (1) on this line insert the name of each minor child you have guardianship of and their date of birth.
- (2) on this line insert the name of the disinterested party who is preparing and filing the Inventory and Appraisal.
- (3) list the personal property of the child(ren). This would include cars, household furnishings, jewelry, bank accounts, etc. It does not include real estate.
- (4) list the appraised value of each item of personal property or bank accounts listed in (6).
- (5) list the any real property or real estate that the child(ren) has an interest in.
- (6) list the appraised value of all real property listed in (8).
- (7) list any source of income the child(ren) receives. This would include any disability payments (SSI), lease income, money from IIM accounts, etc.
- (8) list the anticipated annual amount of income the child(ren) receives.
- (9) on this line insert the day.
- (10) on this line insert the month.
- (11) on this line insert the year.
- (12) on this line insert your name by signing.
