

INSTRUCTIONS FOR FILLING OUT FORM

PURPOSE. This form is to be used when the decedent's will has been admitted to probate and the will nominates a person to serve as Administrator of the decedent's estate and the person nominated consents to serve as Administrator.

FORM INVOLVED. The form is a **Sworn Statement Consenting to Serving as Administrator of the Estate**. You will need to fill in the necessary information with help from the instructions below and then file the form with the court. You must attach a copy to the Petition Requesting Estate be Administered in Probate and file both with the Court to start the probate of the estate.

THE ADMINISTRATOR MUST ATTACH THE SWORN STATEMENT CONSENTING TO SERVING AS ADMINISTRATOR OF THE ESTATE WITH THE PETITION REQUESTING ESTATE BE ADMINISTERED IN PROBATE.

The Tribal Probate code requires that the sworn statement by the person that they are willing to serve as Administrator of the decedent's estate be attached to the Petition Requesting Estate be Administered in Probate.

INSTRUCTIONS FOR FILLING OUT THE FORM. To fill out this form follow these instructions. The numbers to each instruction below is the number on the blank line on the form where the information for that number needs to be inserted on the form. You can print this page in its entirety or you can scroll down to the forms. There will be a blank screen between these instructions and the forms and between the forms so keep scrolling or just copy this page in its entirety.

Instructions for filling out the sworn statement:

- (1) on this line insert the name of the decedent.
- (2) on this line insert the name of the person nominated and consenting to serve as Administrator of the estate.
- (3) on this line insert the day.
- (4) on this line insert the month.
- (5) on this line insert the year.
- (6) on this line insert your name by signing.

Have a notary public notarize the person consenting to serve as Administrator's signature.
