INSTRUCTIONS FOR FILLING OUT FORM

PURPOSE. The Tribal probate code requires the Administrator to immediately send by certified mail copies of the Order to Probate the Estate and any will admitted to probate to the Business Manager of the Rosebud Sioux Tribe and to each heirs, devisee and legatee of the decedent at their last known address that is known to the Administrator. The Administrator is required to prove to the Court that the Administrator sent by certified mail the Order to Probate and any will admitted to probate by filing an affidavit of such mailing within 30 days of the date the Order to Probate the Estate is entered.

FORM INVOLVED. The form is an **Affidavit of Mailing of the Notice of Probate**. You will need to fill in the necessary information with help from the instructions below and then file the forms with the court.

YOU MUST SEND A COPY OF THE ORDER TO PROBATE AND A COPY OF ANY WILL ADMITTED TO PROBATE BY SENDING BY CERTIFIED MAIL TO THE BUSINESS MANAGER OF THE ROSEBUD SIOUX TRIBE AND TO EACH HEIR, DEVISEE AND LEGATEE AT THEIR LAST KNOWN ADDRESS THAT IS KNOWN TO THE ADMINISTRATOR.

The Administrator will want to keep receipts from the Postal Service for proof the Administrator did in fact mail the Order to Probate the Estate and any will admitted to probate to the Business Manager of the Rosebud Sioux Tribe and to each heirs, devisee and legatee of the decedent at their last known address that is known to the Administrator.

FILE THE AFFIDAVIT OF MAILING OF NOTICE OF PROBATE WITH THE CLERK OF COURT AND MAIL COPIES OF THE ORDER TO PROBATE AND A COPY OF ANY WILL ADMITTED TO PROBATE TO THE BUSINESS MANAGER OF THE ROSEBUD SIOUX TRIBE AND TO EACH HEIR, DEVISEE AND LEGATEE BY CERTIFIED MAIL WITHIN 30 DAYS THE ORDER OF PROBATE WAS FILED.
