PURPOSE. This form is to be filled out and signed by the Appointed Appraiser. The Administrator or Appointed Appraiser must file the oath of office with the Court.

FORMS INVOLVED. The form is an **Oath of Office of Appointed Appraiser.** The Administrator or Appointed Appraiser will need to fill in the necessary information with help from the instructions below. The Appointed Appraiser will sign the form and either Administrator or Appointed Appraiser must file the oath of office with the Court.

The Court will appoint a disinterested and competent person as an appraiser to appraise all of decedent's real and personal property in the estate. The appraiser is required to file an oath of office with the Court stating the appraiser has no interest in the estate and that they will honestly, impartially and to the best of their ability appraise all property in the estate using the inventory and appraisal form provided by the Administrator.

The Appraiser must complete oath and file it with the Court before the Appraiser makes an appraisal of the estate. The Administrator may have to ensure the Appraiser completes and files an Oath of Office of Appointed Appraiser.
